- i) you are unable to obtain the relevant Malaysia Class I medical certificate or Malaysia Class II medical certificate (depending on the course selected); or
- ii) you are unable to obtain a letter of approval from the Department of Civil Aviation Malaysia.

There shall be no refund of the enrollment fee for any other reason."
